AP 5055 ENROLLMENT PRIORITIES

References:

Education Code Sections 66025.8, 66025.9, and 66025.92; Title 5 Sections 58106 and 58108

Enrollment Priorities

The District will provide priority registration for students who enroll in a community college for the purpose of degree or certificate attainment, transfer to a baccalaureate-level college or university, or career advancement.

The following students will have the highest and equal priority for enrollment: (Title 5 Section 58108)

- A member or veteran of the armed forces of the United States and is a resident of California pursuant to Education Code Section 66025.8;
- A foster youth, former foster youth, or verified homeless youth or former homeless youth who is not older than 25 years of age at the commencement of the academic year pursuant to Education Code Section 66025.9;
- A student who has been determined to be eligible for Disability Services and Programs for Students (DSPS) or Extended Opportunity Programs and Services (EOPS);
- A student who is receiving aid through CalWORKS;
- A student with dependent children under 18
- A student receiving services from the Rising Scholars Program;
- A student who is a Tribal Temporary Assistance for Needy Families (TANF) Recipient.

The following students will have equal priority for enrollment following the aforementioned groups:

Eligible or pending student athletes pursuant to the Student Athlete Priority
Enrollment Standards and approved by the Athletic Director who have completed
orientation, assessment, and developed student education plans; and are not on
academic nor progress notice for two consecutive terms nor have earned one
hundred (100) or more degree-applicable semester units at the District.

- Currently enrolled first-semester SBCC Promise Program students who are registering for their second semester and eligible continuing SBCC Promise Program students who are not on academic nor progress notice for two consecutive terms nor have earned one hundred (100) or more degree-applicable semester units at the District.
- Eligible Umoja Program students not on academic nor progress notice for two consecutive terms nor have earned one hundred (100) or more degree-applicable semester units at the District.

The following students will have priority for enrollment in the order listed below:

- Eligible students who are current and active officers in the Associated Student Government, during their term(s) of service, who are not on academic nor progress notice for two consecutive terms nor have earned one hundred (100) or more degree applicable semester units at the District.
- Eligible continuing students, who are not on academic nor progress notice for two consecutive terms nor have earned one hundred (100) or more degree-applicable semester units at the District.
- Eligible currently enrolled first semester students, not on academic nor progress notice for two consecutive terms nor have earned one hundred (100) or more degree-applicable semester units at the District.
- First-time students who are local high school graduates, except those with an educational goal of personal enrichment, who have met Local High School Seniors Priority Registration requirements:
 - Submit the SBCC Application for Admission
 - Complete New Student Class Planning including a student education plan
 - Complete Orientation
 - Explore available Financial Aid (optional)
- First-time students who have completed orientation, class planning including student education plan.
- New transfer and returning students, except those with an educational goal of Personal Enrichment, who have met pre-registration requirements and who are

not on academic nor progress notice for two consecutive terms nor have earned one hundred (100) or more degree-applicable semester units at the District.

- Students enrolled in the SBCC Middle College Program and/or local CCAP Dual Enrollment Program, who are not on academic nor progress notice for two consecutive terms nor have earned one hundred (100) or more degree-applicable semester units at the District.
- Students with an educational goal of Personal Enrichment and/or those students who have lost their priority registration as defined by the criteria below.
- All other Dual Enrollment students not previously included in Middle College or CCAP programs.
- Open registration including Noncredit students.

Registration start dates for each of the above cohorts will be stipulated by the Chief Student Services Officer or designee as approved by the Student Affairs Leadership Committee.

Loss of Enrollment Priority

The registration priority specified above shall be lost at the first registration opportunity after a student:

- is placed on academic or progress notice or any combination thereof as defined in BP and AP 4250 titled notice for two consecutive terms; or
- has earned one hundred (100) or more degree-applicable semester units at the District.

For purposes of this section a unit is earned when a student receives a grade of A+, A, A-, B+, B, B-, C+, C, D+, D, D-, or P as defined in AP 4230 titled Grading and Academic Record Symbols. This 100-unit limit does not include units for non-degree applicable English as a Second Language or basic skills courses as defined by the Chief Instructional Officer.

The District shall notify students who are placed on academic or progress notice, of the potential for loss of enrollment priority. The District shall notify the student that a second consecutive term on academic or progress notice will result in the loss of priority registration as long as the student remains on notice.

The District shall notify students who have earned 75 percent or more of the unit limit that enrollment priority will be lost when the student reaches the unit limit.

Appeal of Loss of Enrollment Priority

Students may appeal the loss of enrollment priority when the loss is due to pursuit of a high-unit major or extenuating circumstances. Extenuating circumstances are verified cases of accidents, illnesses, or other circumstances beyond the control of the student, or when a student with a disability applied for, but did not receive a reasonable accommodation in a timely manner. The Chief Student Services Officer or designee will be solely responsible for determining the outcome of the appeal.

The District will ensure that these procedures are detailed on the District's website.

Enrollment Limitations

Enrollment in courses and programs may be limited to students meeting properly established prerequisites and corequisites (See BP and AP 4260 titled Prerequisites and Co-requisites).

Enrollment may be limited due to the following:

- health and safety considerations;
- facility limitations;
- faculty workload;
- availability of qualified instructors;
- funding limitations;
- regional planning;
- legal requirements; and
- contractual requirements.

When enrollment must be limited, priorities for determining who may enroll are: (Title 5 Section 58106)

- based on a first come, first served, or other non-evaluative selection techniques;
- in the case of intercollegiate competition, honors courses, or public performance courses, allocating available seats to those students judged most qualified;
- limiting enrollment to any selection procedure expressly authorized by statute;

 limiting enrollment in one or more sections to students enrolled in one or more other courses, provided that a reasonable percentage of all sections of the course do not have such restrictions.
